**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#21 is a tall, 2-1/2 story detached brick house approximately three bays square with a 1-1/2 story brick "L" shaped wing three bays deep and two bays wide with a steep sloped shed roof and overhang, a 1-1/2 story brick dependency and a wing side one bay square, one story brick extension. All brickwork is in common bond. The front entrance occupies the left (W) bay with a newer door, paneled enframing, four pane overlight and a dentiled transom bar. Front windows on the first floor are now of 1/1 sash with 6/6 sash above, all with moulded top lintels. Rear area windows are mostly of 6/6 sash with wood lintels and sills. The attic of the front section is lighted by two 6/3 sash windows on the left and one on the right. The wing has two 6/6 peaked dormer windows. The front section has a moderate slope "A" frame roof resting on three string brick cornices. A wide four flue enclosed chimney rises on the right side with the remains of a duplicate on the left. End walls rise to form roof curtains with end buttresses. The wings have steep shed roofs and all are of metal. This house rests on a low fieldstone foundation but the cellar is mostly above ground with high brick walls necessitating nine steps to the front door. It is fronted by a herringbone patterned brick pavement. There are lawn and garden areas to the rear.
