DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#105 is a 2-1/2 story brick house detached on the right (E) side, four bays wide and two bays in depth with a 2-1/2 story brick "L" shaped wing 1-1/2 bays wide and four in depth and an enclosed balcony. All brickwork is in common bond. A newer door with narrow overlight occupies the second bay from the left. All regular house windows are now of 1/1 sash with wood lintels and sills. The front section attic is lighted by two, four pane windows on the right side and the wing has a 4+4 pane casement window in the rear gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices with the middle row of the front being in a dentil pattern. Double flue enclosed chimneys rise from each end. The wing also has a moderate slope "A" frame roof and both are of metal. This house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
