DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#107 is a 2-1/2 story brick house detached on the left (W) side, four bays wide and two bays in depth with a two story brick "L" shaped wing, two bays wide and three bays deep, a side balcony and a one story brick extension. All brickwork has been restored revealing a light salmon shade to the second story and a darker red brick above indicates the second story was added within the Federal period. All is in common bond. The front entrance occupies the second bay from the right (E) side with a new door but with the narrow overlight blocked in. All front windows are now of 1/1 sash and rear area windows retain the 6/6 sash, all with wood lintels and sills. The attic is lighted by two small four pane windows in the left gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices with the front center now in a dentil design. A double flue enclosed chimney rises from each end. The metal roof is said to cover wood shingles. The wing has a metal shed roof. This house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement. Old rafters are said to be wood pegged.
