DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The old Moose Lodge is a 2-1/2 story brick house three bays wide and three bays in depth with a two bay wide and one bay wide right side extension. There is also a two story, three bay deep, full width added wing to the rear with a newer block extension. The original house on the left is of Flemish bond with a high, moulded top Flemish bond watertable. The next section is of common bond but with an extended Flemish bond watertable and different capping. The newer, right side extension is also of common bond with no watertable. A three string belt course with the top now protruding crosses the building beneath the second story windows. The entire right wall is of newer construction. The original entrance occupies the left (E) bay with a six panel door. The newer right bay now is used as the main entrance with a newer three part Federal imitation doorway with the door having six panels with sidelights and overlights. Front windows are now 2/2 sash with wood lintels and sills and side windows are of 6/6 sash with metal lintels. The attic is lighted by a 6/6 sash window on the right side. The front section has a steep slope metal "A" frame roof with a boxed cornice and a large chimney rises from the right side of the original house (off center with the present roof). The building rests on a low fieldstone foundation.
