DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#109 is a 2-1/2 story brick house detached on the right (E) side, four bays wide and two bays in depth with an "L" shaped, two story brick wing approximately two bays wide and five bays in depth with a long side balcony. All brickwork has been restored revealing a light salmon color and is in common bond. The front entrance occupies the second bay from the left with a four paneled door, paneled enframent, and four pane overlight. First floor front windows are now of 6/1 sash with 6/6 sash remaining on the second story. The wing has small 9/6 sash windows with handblown glass and small frames on the first floor and 6/6 sash on the second story. The front windows are adorned with the wood lintels having square end blocks with carved roundels, as above the door and rear windows have regular wood lintels and sills. There is a four panel kitchen door with a four pane overlight. The attic is lighted by two small four pane windows in the right gable. The front section has a rather steep slope metal "A" frame roof said to cover old wood shingles. This rests on three string and two string brick cornices. A large enclosed chimney rises from each end. The wing has a metal shed roof. This house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
