**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#111 is a 2-1/2 story attached brick house three bays wide and two bays in depth with a one story brick and frame shop one bay wide extension on the left (W) side. A newer full width, four bay deep, frame extension has been built onto the rear. All brickwork is in common bond. The main entranceway occupies the right (E) bay with a newer door, paneled enframing and narrow overlight. Front windows are of 2/2 sash with flat brick arches. The shop addition has a large window and door and the attic is lighted by two small four pane windows in the left gable. The front section has a steep slope "A" frame roof resting on three string brick cornices and double flue enclosed chimneys rise from each side. The rear extension has a rather flat roof. This house rests on a low fieldstone foundation.
