7-9 South Market Street is a three story Italianate style commercial building, four bays wide and approximately five bays in depth with a balcony on the rear of the third level. This late nineteenth century building is particularly characterized by a heavy ornate cornice with fluted brackets, dentil molding, and brackets ends which are

connected by a wood band decorated by applied squares. The building is constructed of brick laid in a common bond, off-white or yellow pressed brick on the facade and common red brick on the sides. Another significant feature of the building is the large wood entablatures which grace all front windows on the second and third level. Each entablature is decorated with incised floral decoration and is supported by scrolled brackets. All windows are 2/2 sash with segmental brick arches.

The storefront of the building was applied c. 1950 when the building became the tire store for Sears and Roebuck. A corrugated tin material appears to have been placed over an earlier storefront which will be rehabilitated as part of the project. The tin presently covers the transom and apron areas, the remainder of the storefront is plate glass with an aluminum front door and frame. Above the storefront is the original cornice supported by end brackets and decorated with dentil molding and architrave molding. A side door leads to the residential area on the upper levels. This doorway which appears to be original to the present building facade is a glass paneled door with a large high transom and is decorated by dentil molding on the cornice and lower panel of the door. The entrance is reached by two granite steps. The brick work is rusticated on the first floor of the building around the residential entrance and storefront.





The rear part of the building is entirely enveloped by a larger building used as the main Sears store which stands in an ell with this building. The visible part of the rear of this building is covered with clapboard sheathing. The roof is a built up shed roof.

The first floor interior of the building is partially covered with plywood paneling but retains a pressed tin ceiling. The second and third levels have always been used for residential use and display typical woodwork such as circular corner block and heavy lacquered egg and dart molding on the staircases typical to the period of construction of this building.

Statement of significance, continued

is a particularly ornate one in the Frederick commercial historic district and has not been altered. The building contributes significantly to the streetscape of South Market and is also individually significant for the quality of workmanship that the woodworking on the building exhibits.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a rectangular, three story brick attached building, four bays wide, approximately five bays in depth, with a balcony on the rear of the top story. The building is faced with an off-white pressed brick and the sides are of regular brick, both in common bond. First floor brickwork is rusticated on either side of the store windows. The visible part of the rear elevation is of clapboard sheathing. The main doorway to the shop is off center with large plate glass windows on either side and is masonry covered with corrugated metal above and below the windows. To the right is the apartment entrance containing a glass paneled door and a high transom with a dentil trimmed transom bar. The first story is headed by a molded cornice supported by carved brackets at either end and trimmed by a double row of dentils. Upper story windows are of 2/2 sash with segmental brick arches and crowned by flat entablature cornices supported on consoles with the architrave decorated with incised scrolls and dentils. There are no side windows and rear windows are not visible. The entire roof slopes to the rear. A small chimney rises above the left wall. The front roofline is capped by an ornate cornice with fluted brackets, a row of dentils, a row of lozenges with roundels, incised molding and bracket ends are tied together by a wood band of pyramid fronted squares below the frieze. The building rests on a low foundation.
