DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of two story brick houses detached on the right (E) side and is seven bays wide and three bays deep with two story "U" shaped brick wings 1-1/2 bays wide and four bays long with remains of a side balcony. This building is of unpainted common bond. Period doors of panels occupy the end bays with white marble sills, segmental arched transoms and moulded transom bars. These are approached by ornamental three step cast iron porches. A segmental arched gateway in the center bay leads to an enclosed passageway to rear yards. All front windows are of 1/1 sash with segmental brick arches. Wing windows are of 6/6 sash with wood lintels and sills. Cast iron grates with cherub faces, possibly an early local product, guard the front cellar windows. The front roof section slopes to the rear and the wings have shed roofs. The front roof cornice overhangs with closely spaced modillions. The house rests on a low fieldstone foundation and is fronted by a herringbone pattern brick pavement.
