DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#117 is a tall, 2-1/2 story brick house detached on the left (W) side, three bays wide and two bays in depth with a two story brick "L" shaped wing 1-1/2 bays wide and two bays deep and a rear gallery. Front brickwork is laid in Flemish bond. A newer door with a narrow overlight occupies the center bay. Front windows are now of 1/1 sash, the rear of the front section retains 6/6 sash and the wing has 2/2 sash, all with wood lintels and sills. The attic is lighted by two small four pane windows in the left gable. The front section has a moderate slope "A" frame roof resting on two string brick cornices and small enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. The house sets on a high fieldstone and brick foundation with eight steps to the front door. It is fronted by a herringbone patterned brick pavement.
