DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached row of four frame houses eight bays wide and two bays in depth with 1-1/2 story frame wings one bay wide and two bays in depth. These are "L" shaped for #119 & 125 and #121 & 123 share a "T" shaped wing. The building is sheathed with clapboarding on the front and rear and asbestos shingles on the sides. Simple front entrances occupy the right (E) bays of #119 & 121 and the left bays of #123 & 125 with glass over panel doors, four pane overlights, and pierced transom bars. Enclosed passageways to rear yards lie between the second and third and sixth and seventh bays from the right. All house windows are of 6/6 sash in old narrow frames and wing attics are lighted by small four pane windows. The front section has a moderate slope "A" frame roof and double flue chimneys rise between each pair of houses. The wings have steep slope shed and "A" frame roofs and all are of metal. This building sets on a rather high fieldstone foundation and is fronted by a herringbone patterned brick pavement.
