DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the left (E) side with a frame carriage house addition on the right side. It is four bays wide and three bays in depth with a newer first floor, full width extension. Newer doors occupy the inner bays with #126A having the original entrance with a paneled enframent, overlight, and segmental brick arch with the infill decorated by roundels as on the upper story windows. A center bay window projects above the doors and other front windows are of 2/2 sash with two row header segmental brick arches. Rear windows have 6/6 sash with wood lintels and sills. All brickwork is laid in common bond. The front section has a steep slope "A" frame roof resting on two string brick cornices and is covered with embossed metal work. Enclosed chimneys rise from each gable. This house rests on a low fieldstone foundation.

To the right is an attached frame Carriage House of vertical siding with a 2/2 sash top window and a wide gate and door of vertical siding. This is headed by an ornate Victorian cornice trimmed with dentils and scallops. A herringbone patterned brick pavement fronts the house and a brick driveway of the sides facing up leads to the carriage house and probably an early stable beyond.
