DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an old log detached pair of houses, probably built as one unit four bays wide and two bays in depth sharing a 1-1/2 story frame "T" shaped wing four bays deep and three bays wide. The front and sides are now sheathed in aluminum siding and the back wall is covered with board and batting. The wing is covered by clapboarding and asphalt brick patterned material. Front entrances occupy the inner bays with glass over panel doors and all house windows of 6/6 sash in old thin frames and louvered shutters. The doorways are protected by a newer pent roof. A small four pane window lights the attics from each end. The front section has a steep slope "A" frame roof with double flue chimneys enclosed in each end. The wing has a moderate slope "A" frame roof with an overhang on each side and a large chimney at the end. All roofing is now of metal over wood shingles. Roof cornices are boxed. This building rests on a rather low fieldstone foundation.
