**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick pair of houses four bays wide and three bays in depth with the second story being the main floor entered from the right (W) side by a long covered porch of framing. The first floor has been converted into apartments and both stories now have newer doors with covered overlights. Side and rear walls are of local fieldstone through the second story. The front facade is now of brick laid in common bond. This pair of houses originally had two separate entrances as indicated by large granite steps at the base of the present steps and on the other end. All house windows are now of 1/1 sash with wood lintels and sills. The roof is of moderate slope "A" frame construction resting on two and three string cornices and with wide enclosed chimneys at each end. This building rests on a low fieldstone foundation with the first floor (formerly cellar) partly below the pavement level.
