DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#131 is a two story detached frame building with a rear balcony and covered with clapboarding. The first floor is occupied by a beauty shop with large paned windows and door with a small paned apartment door. The front facade is topped by a capped flat wooden parapet projecting above a boxed cornice marking the roof-line. All house windows are of 1/1 sash on the second story and side and rear first floor windows are of square six pane sash. The metal roof is rather flat. The building rests on a low foundation.
