DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of 1-1/2 story brick houses detached on the right (W) side. It is four bays wide and approximately three bays in depth with a one bay deep, 3-1/2 bay wide original extension and long sloping, Colonial "cat - slide roof." Brickwork is very old and laid in common bond. Simple front entrances occupy the inner bays with new doors and covered narrow overlights. All windows are now of 1/1 sash with either concrete or wood lintels and sills. The moderate slope "A" frame roof is covered with asphalt shingles and the attic is lighted by two small peaked dormer 1/1 sash windows on the front. The front roofline rests on a two string brick cornice and a double flue chimney rises from the center of the ridge and from the center of the rear wall. The building has a low fieldstone foundation.
