## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#137 is a large, two story brick house detached on the right (E) side, three bays wide and two bays in depth with a two story brick "L" shaped wing approximately five bays long and one bay wide with a long side balcony. All brickwork is in common bond and the front is faced with a light red pressed brick. Double doors of small panels occupy the left bay with a narrow overlight and concrete lintel and sill as do all front windows. These windows are of 1/1 sash with second story louvered shutters. The wing has 6/6 and 2/2 sash with wood lintels and sills. An old 1/1 JIB window-door is located on the rear of the front section. There are old four panel doors and four pane overlights. The front section roof slopes to the rear and the wing has a shed roof. The front facade is topped by a corbelled brick frieze and a cornice trimmed with long modillions. This house sets on a rather high concrete faced foundation and is fronted by a herringbone patterned brick pavement.
