DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses detached on the left (W) side five bays wide and two bays in depth with two story brick "U" shaped wings four bays deep and 1-1/2 bays wide with end balconies. All brickwork is in common bond. Newer doors occupy the end bays with paneled enframements and narrow overlights. A board and batten door in the center bay guards an enclosed passageway to rear yards. The first floor inner bays contain double windows with top moulded mullions and all front windows are of 1/1 sash with wood lintels and sills. The wing area retains old 6/6 sash with wood lintels and sills, and there are four panel kitchen doors, one now with glass. The front section has a moderate slope "A" frame roof resting on two string brick cornices with small enclosed chimneys on each end. The attic of #139 is lighted by a skylight and #141 by a small four pane window in the left gable. This building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
