**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#140 is a 2-1/2 story brick house detached on the left (E) side, three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and four bays in depth with a side balcony and one story brick extension. All brickwork is in common bond. A newer front door with a narrow overlight occupies the right (W) bay and all front windows are of 1/1 sash with wood sills and top moulded lintels. Wing windows are of 2/2 sash with wood lintels and sills and there is a four panel kitchen door. The attic is lighted by a small 2/2 sash in the left gable and double flue chimneys rise from each side. The front section has a steep slope "A" frame roof resting on two string brick cornices and the wing has a shed roof with both being of metal. The house rests on a low fieldstone foundation. It is fronted by a herringbone patterned brick pavement and has a wingside patio.
