DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#142 is a 2-1/2 story brick house detached on the right (W) side, three bays wide and two bays in depth with a two story brick "L" shaped wing four bays deep and two bays wide with a side balcony and newer one story brick extension. All brickwork is in common bond. A newer front door occupies the left (E) bay with an overlight and scalloped transom bar. Front windows are of 1/1 sash with two row header segmental brick arches with the infills decorated by incised scrollwork. Rear windows are of 2/2 and 6/6 sash with wood lintels and sills. The front section has a moderate slope "A" frame roof resting on a two string brick cornice on the rear and a three string cornice on the front with the center row laid on the horizontal dog-tooth design. A small enclosed chimney rises from the right side beside remains of a former attic window. The wing has a shed roof and both are of metal. The house rests on a field-stone foundation.
