**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#143 is a 2-1/2 story detached brick house four bays wide and two bays in depth with a two story brick "L" shaped wing two bays square with a side balcony and one story brick extension. All brickwork is in common bond. The second bay from the left (W) side contains a newer front door with a paneled enframing, narrow overlight, and dentiled transom bar. This is approached by a brick porch and wrought iron railing. All front windows are of 1/1 sash and wing windows remain 6/6 sash, all with wood lintels and sills. There is a four panel kitchen door with a three pane overlight. The attic is lighted by two, four pane windows in the left gable and one on the right. The front section has a steep slope "A" frame roof resting on three string brick cornices with enclosed double flue chimneys rising from each end. The wing has a shed roof and both are of metal. This house rests on a rather low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
