DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story detached brick pair of houses four bays square with a two story brick "T" shaped wing two bays deep and three bays wide beveled into the front section and with rear balconies. All brickwork is in common bond. Front entrances occupy the outer bays with period doors, segmental arched transoms and transom bars with Victorian "V" shaped cut motifs. The inner bays contain double 1/1 sash windows with moulded mullions. Upper story windows have 2/2 sash windows and two row header segmental arches as those below, but the infills are decorated with roundels. Rear area windows are also of 2/2 sash with two row header segmental brick arches. The front section roof slopes to the rear and the wing has a low "A" frame roof. The Victorian "V" shaped cornice is richly moulded. The building sets on a rather high fieldstone foundation and is fronted by a herringbone patterned brick pavement.
