DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached 2-1/2 story pair of brick houses four bays wide and approximately three bays in depth with a two story brick "T" shaped wing two bays square and several two story brick side and rear extensions and side balconies. All brickwork is in common bond. Newer doors occupy the right (E) bay of each house with #149 retaining a three pane overlight. Most house windows are now of 1/1 sash except for the front and side of the second story of #149 which retain 6/6 sash and all have wood lintels and sills. The attics are lighted by a 6/6 sash window in the gable of #147 and two 6/6 sash in the #149. The front section has a moderate slope "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each end. The wing has a shed roof and is of metal. The houses rest on a low fieldstone foundation.
