**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached pair of 2-1/2 story brick houses four bays wide and approximately three bays in depth with a two story brick "T" shaped wing two bays deep and three bays wide with rear balconies. All brickwork is in common bond. Front entrances occupy the outer bays with newer doors and segmental brick arched transoms. The first floor inner bays contain wider windows with transoms and dentiled transom bars. Second story front windows are of regular size with louvered shutters and all are of 1/1 sash. Side and rear windows are of 2/2 sash with two row segmental arches. The attics are lighted by small four pane windows in each gable. The front section has a moderate slope "A" frame roof resting on string brick cornices and small enclosed chimneys rise from each side. The wing has a low "A" frame roof and both are of metal. This building sets on a rather high fieldstone foundation. The front pavement is laid in a herringbone patterned brick design.
