DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached row of three brick two story houses, seven bays wide (153-3 bays) and approximately five bays in depth with rear balconies. All brickwork is of common bond. Newer doors occupy the left bay of #149 and the right bays of the other houses. Entrances are protected by a wide covered porch supported by Doric pillars. All house windows are of 1/1 sash with wood lintels and sills. The metal roof slopes to the rear and the front cornice is boxed with a wooden frieze and has dentil trim. This building sets on a rather high fieldstone foundation and the houses set back from the pavement with grass plots.
