DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#200 is a two story brick detached house three bays wide and two bays in depth with a two story brick "L" shaped wing four bays deep and two bays wide with side galleries. All brickwork is in common bond. The front entrance occupies the right (W) bay with double doors of panels, round arched transom, and transom bar decorated with cut "V" shaped motifs. To the left is a wide, elliptically arched triple window with fluted and turned attached pillars adorning the mullions. Second story front windows are segmentally arched with two row brick headers, have louvered shutters, and all have 1/1 sash. Rear area windows are of 2/2 sash with two row brick header segmental arches and louvered shutters. The front section roof slopes to the rear and the wing has a shed roof, all of metal. The front roofline has a Victorian "V" shaped cornice adorned with bands of moulding, rounded dentils and beading. Fluted and moulded brackets are at the center and ends of the cornice. This house sets on a low fieldstone foundation but has high brick cellar walls. The front pavement is laid in a brick herringbone design.
