**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a two story pair of detached brick houses four bays wide and approximately six bays in depth with rear balconies. Brickwork is of unpainted common bond. Period glass paned doors occupy the inner bays with narrow overlights and are headed by two row segmental brick arches as are all house windows. Those windows are all of 1/1 sash. Front entrances are protected by a wide covered porch supported by Doric pillars. The metal roof slopes to the rear and is fronted by an overhang boxed cornice with a wood frieze ornamented with dentils. The building sets on a rather high fieldstone foundation and is located back from the pavement with grass plots between the walks.
