DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#202 is a 2-1/2 story detached brick house three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and four bays in depth with a side balcony and newer one story brick extension. All brickwork is in common bond and unpainted sidewalls reveal old hand made brick. The front entrance occupies the right (W) bay with a newer door, segmentally arched transom with the transom bar trimmed in the old egg and dart motif. This is headed by a brick arch of two rows of headers as are all front windows. These windows are of 1/1 sash and rear area windows are of 2/2 and 6/6 sash with wood lintels and sills, mostly with louvered shutters. The attic is lighted by small four pane windows in each gable. The front section has a rather steep slope roof of asbestos shingles resting on two string brick cornices and small enclosed chimneys rise from each end. The wing has a shed roof. This house rests on a low fieldstone foundation. There is a dooryard brick patio, rear area flower area, and brick walks.
