DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of brick houses four bays wide and approximately three bays in depth sharing a two story, brick "T" shaped wing two bays square with side balconies. All brickwork is in common bond and #206 is also covered with brick patterned formstone. Newer doors occupy the outer bays with segmentally arched transoms and dentiled transom bars. The arched infills are decorated by roundels as above all front windows. Wide windows occupy the inner bays of the first floor with regular windows above and all are of 1/1 sash. Rear windows are of 2/2 sash with wood sills and lintels. Small windows in each gable light the attics. The front section has a moderate slope "A" frame roof resting on two string brick cornices and small enclosed chimneys rise from each gable. The wing has a low slope "A" frame roof and both are of metal. This building rests on a low fieldstone foundation.
