DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#208 is a two story brick detached house three bays wide and two bays in depth with a two story brick "L" shaped wing four bays deep and two bays wide with a side balcony. The front facade has been covered with "formstone." The front entrance occupies the right (W) bay with a newer door, transom, and a dentiled transom bar. Front windows are of 1/1 sash and those on the rear are of 2/2 sash both with wood lintels and sills. The roof of the front section slopes to the rear and the wing has a shed roof. The front Victorian "V" shaped roof cornice is rather simple with moulding and incised diagonals. The house rests on a low fieldstone foundation.
