DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story brick pair of houses four bays wide and four longer bays in depth, sharing a two story brick "T" shaped wing three bays wide and two bays in depth beveled into the front section and with rear balconies. Brickwork is in painted common bond. Simple front entranceways occupy the outer bays with period doors and segmental arched transoms with three rows of headers and the top row protruding as a drip mould. First floor windows are double with fluted and moulded mullions. Second story windows are of regular size with segmental arches of brick. All have 1/1 sash and drip moulds as above the front doors. Side and rear area windows are of 2/2 sash with wood lintels and sills. The front roof section slopes to the rear and the wing roof has a low "A" frame. The front Victorian "V" shaped cornice is adorned with bands of beading, rounded dentils, and mouldings. Fluted brackets divide and end the houses. The building rests on a low fieldstone foundation and #210 is fronted by a herringbone brick pavement.
