DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of brick houses two stories in height, four bays wide and two bays in depth, sharing a two story brick "T" shaped wing, three bays wide and four bays in depth with rear balconies. The front facade is of unpainted pressed brick, all is in common bond, and a two row projecting brick belt course crosses between the front second story window sills. Wide entranceways occupy the outer bays with paneled double doors and a newer brick porch on #217. These doors are topped by three row header, segmental brick arches with infills decorated by roundels, as above all front windows, and there are wide door transoms with scalloped transom bars. Front windows are of 1/1 sash with two row header segmental arches, and those on the rear are of 2/2 sash, also with the above-mentioned arches, and most have louvered shutters. The front section roof slopes to the rear and the wing has a low "A" frame roof. The front Victorian cornice is decorated by an attached cylinder divided by projecting disks and topped by a row of scallops. There is a wood paneled frieze. This building sets on a rather high fieldstone foundation. The houses were apparently built at the same time by the same builder of #221 & 223.
