**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached two story pair of brick houses four bays wide and three bays deep sharing a two story brick "T" shaped wing three bays wide and two bays deep with rear balconies. All brickwork is in common bond. Simple front glass paned doors occupy the outer bays with transoms headed by two row segmental brick arches as are all house windows. #222 is entered by a four step cast iron porch. All windows are of 1/1 sash on the front and 2/2 sash on the rear areas. The front roof slopes to the rear and the wing has a low "A" frame roof. The front cornice is boxed and trimmed with dentils and incised diagonals. The houses rest on a low fieldstone foundation but have bricked up cellar walls. They are fronted by a herringbone patterned brick pavement.
