DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of brick houses two stories in height, four bays wide and two bays in depth sharing a two story brick "T" shaped wing three bays wide and four bays in depth with rear balconies. The front facade is of unpainted pressed brick, all in common bond, and a two row projecting brick belt course crosses between the front second story window sills. Wide entranceways occupy the outer bays with #221 retaining paneled double doors and #223 has a newer wide door. These are topped by three row header segmental brick arches with the infills decorated by roundels, as are all front windows and there are wide door transoms with scalloped transom bars. Front windows are of 1/1 sash with two row header segmental arches and those on the rear area are of 2/2 sash, also with the above-mentioned arches, but mostly with louvered shutters. The front section roof slopes to the rear and the wing has a low "A" frame roof. The front Victorian cornice is decorated by an attached cylinder divided by projecting discs and topped by a row of scallops. There is a wood paneled frieze. This building sets on a rather high fieldstone foundation. It is fronted by a herringbone patterned brick pavement and front lawn areas. These houses were apparently built at the same time by the same builder as #217-219.
