DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of two story brick houses four bays wide and five bays in depth with enclosed rear balconies. The front facade is faced with brighter red brick and all is in common bond. Period doors occupy the inner bays and are protected by a large, double covered porch with Doric columns. All house windows are of 1/1 sash with two row header segmental arches as above the doors. The metal roof slopes to the rear and is fronted by a simple overhanging boxed cornice ended by small fluted brackets. The building sets on a rather high fieldstone foundation.
