DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story detached brick double house, four bays wide and five bays in depth with a rear balcony, enclosed on #433. All brickwork is in unpainted common bond. Period doors occupy the inner bays and are protected by a large double covered porch with Doric columns. All house windows are of 1/1 sash with wood lintels and sills. The metal roof slopes to the rear and is fronted by an overhanging boxed cornice with dentil trim. The building rests on a low fieldstone foundation.
