DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#300 is a large detached 2-1/2 story brick home, approximately three bays square, and a newer small one story frame extension to the rear. All brickwork is in common bond.

A newer door occupies the right (W) bay with a rectangular transom, and the house is fronted by a full-width covered Victorian porch with turned pillars and a cornice cut in a lily design.

All windows are of 2/2 sash with two row brick header segmental arches and infills are adorned with a moulded scroll design. The attic is lighted by small four pane windows in the side gables.

The steep sloped metal "A" frame roof rests on a two string brick cornice and square enclosed chimneys rise from each end. The house sets on a fieldstone foundation.
