DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story detached pair of brick houses four bays square with a two story brick "T" shaped wing three bays wide and two bays deep with side balconies. All brickwork is in common bond.

Simple entrances occupy the outer bays with ~~pan~~ doors of the period. First floor front windows are double with 1/1 sash, reeded mullions topped by roundels, and elliptical arches--unusual for this cost category. Those above are also of 1/1 sash but with segmental brick header arches, as on the sides and rear. These rear area windows are of 2/2 sash.

The metal roof of the front section slopes to the rear and is fronted by a Victorian "V" shaped cornice trimmed by bands of mouldings and incised decor. The building rests on a low fieldstone foundation.
