**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#9 is now a 2-1/2 story stone and brick house, detached, approximately three bays square, with a two story stone "L" shaped wing, two bays wide and three bays in depth with a side balcony and clapboarded frame, two story extension being one bay in depth. The front section has a rough-coursed fieldstone first floor, probably quarried from a nearby outcropping and the second story is of common bond brick, recently restored.

The front entranceway occupies the right (E) bay with a newer door, paneled enframingent, and three pane overlight. All front windows are now of 1/1 sash with wood lintels and sills and second story lintels are top moulded. Rear area windows are of 6/6 or 2/2 sash with wood lintels and sills. The attic is lighted by two 6/6 sash windows in each gable. The front section has a steep slope "A" frame roof resting on two string brick cornices covered by wood moulding on the front. Double flue enclosed chimneys rise on either side. The wing has a shed roof and both are of metal. The house rests on a rather low fieldstone foundation.
