DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#13 is a tall, 2-1/2 story brick house detached on the right (E) side, three bays wide and two bays in depth with a two story, brick "L" shaped wing, two bays wide and five bays in depth, a side balcony and the remains of a one story brick dependency with wall louvers, one bay wide and two bays in depth. All brickwork is in common bond. The front entrance occupies the left bay with a newer door, paneled enframent, four pane overlight, and moulded transom bar. Front windows are now of 1/1 sash on the first floor and 6/6 sash on the second floor, all with wood lintels trimmed with end blocks bearing roundels, as above the door. There are small four paned cellar windows. Rear windows are of 6/6 sash with wood lintels and sills and several have old paneled shutters. There are four panel rear doors with four pane overlights. The attic is lighted by a six pane window in the right side. The front section has a steep slope "A" frame roof resting on three string brick cornices and a double flue enclosed chimney rises in front of the ridge line on the right side. There is also a very wide chimney at the left side. The wing has a shed roof and both are of metal. This house sets on a high fieldstone foundation and is fronted by a herringbone brick patterned pavement.
