DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick pair of houses detached on the right (E) side and approximately four bays square, sharing a two story brick "T" shaped wing three bays wide beveled into the front and two bays in depth with end balconies. All brickwork is in common bond and the front facade is trimmed with three string belt courses crossing at the first floor door transom level and at the heads of second story windows. The front entrances occupy the first and third bays from the left with period doors, white marble sills and round arched transoms with moulded transom bars. To the right of these are wide 1/1 sash windows with segmental arched transoms and dented transom bars. Upper story front windows are of 1/1 sash with segmental arches, all being of two rows of header brick. There are 2/2 sash windows on the rear and the wing has 6/6 sash with wood lintels and sills. Rear doors are of four panels. The front roof slopes to the rear with the wing roof being rather flat. The front Victorian cornice is "V" shaped and decorated with bands of mouldings and incised crosses. The houselines are divided and ended by three narrow moulded brackets. This pair of houses rests on a low fieldstone foundation but has high brick cellar walls. It is fronted by a herringbone patterned brick pavement.
