DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#5 is a two story brick house detached on the right side, three bays wide and four in depth with a rear balcony. All brickwork is in common bond. A period door occupies the right (E) bay. All front windows are of 1/1 sash with two row header segmental brick arches with the infills decorated by roundels as over the door. A bay window projects from the left bay. Rear windows are of 6/6 sash with two row header segmental arches. The roof slopes to the rear and is fronted by a "V" shaped Victorian cornice with bands of "V" shaped incissions and mouldings. This house rests on a low fieldstone foundation with high brick cellar walls.
