DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#11 is a two story brick house detached on the right (E) side, three bays wide and two bays in depth with a two story brick "L" shaped wing 1-1/2 bays wide and four bays in depth with an enclosed side balcony. All brickwork is in common bond. The front entrance occupies the left (W) bay with a paneled door of the period. All front windows are of 1/1 sash with two row header brick segmental arches and rear windows are of 2/2 sash with wood lintels and sills. The front section roof slopes to the rear and the wing has a shed roof. The front roofline has an unusual metal embossed cornice, ornamented by bands of patera, foliated garlands and squares bearing fleur-de-lys. The house rests on a low fieldstone foundation with high brick cellar walls and is fronted by a brick pavement.
