**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story brick attached building now divided into apartments. It is six narrow bays wide and five bays long with "U" shaped wings, two bays wide by approximately four bays long and two stories high. Balconies are on the ends of the wings. The front facade is of a hard pink-toned pressed brick with the sides and rear of regular brick, all in common bond. Simple flat topped doorways occupy the first and sixth bays and contain glass paneled doors with vestibules, transoms with bars trimmed by dentils. These are reached by four step cast iron porches. All front windows are of 1/1 sash while those on the rear are 2/2 panes with segmental brick arches and wood lintels. The front second floor inner four bays are lighted by two wide bay windows supported by brackets. There is much granite work on the front facade such as window sills, 3' high ground level facing and an approximately 8" granite belt course or band across the building under the bay windows. There are also decorative granite panels above this band in the first and sixth bays. The roof of the front section slopes to the front and the wings have shed roofs, all of metal. There are two chimneys on the rear of the front section as well as the rear of the wings. The front roofline is edged by a simple cornice supported by modillions and decorated by pendants on either end. The raised brick frieze is adorned by brick squares and a molded cornice at its base. This building rests on a high fieldstone foundation with front entrance doors to the basement.
