DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story masonry attached building with the first floor of stone and a brick top story, all now stuccoed on the front. It is eight (8) narrow bays wide and approximately three bays in depth with a rear balcony. There are several small doors of differing vintage on the front and rear of the first floor. Second story rear doors are of an old six panel type with four pane overlights. All second story windows are of 6/6 sash with old frames. The front of the top half story is lighted by small 4+4 casement "lie on your stomach" windows with wood lintels and sills. The rear of the attic is lighted by two small shed roofed dormer windows of 6/6 panes. The building has a moderate slope "A" frame roof resting on three string brick cornices and a newer large chimney rises off center near the front wall. This building rests on a low fieldstone foundation.
