DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story row of three brick houses detached on the left (W) side nine bays wide and two bays in depth. Each house has a two story brick "L" shaped wing two bays deep and 1-1/2 wide with a side balcony and frame summer kitchen. All brickwork is in common bond. Paneled doors with transoms occupy the first, fourth, and seventh bays from the left. Gateways with board and batten gates and Victorian-cut grills separate the houses and lead to enclosed passageways to the rear yards. First floor front windows are double with 1/1 sash, moulded mullions and headed by flat brick arches of long shaped voussoirs, as above the doors. Second story front windows are of 2/2 sash with moulded top lintels. Wing windows are of 6/9 sash with wood lintels and sills. The front section and wing roofs slope to the rear and is fronted by an overhanging cornice with mouldings and closely-spaced, cyma curved modillions bearing crockets of floral motifs. Ornate brackets end the cornice. The houses rest on a low fieldstone foundation. #13 and 15 retain brick pavement.
