DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#19 is a tall, 2-1/2 story brick detached house three bays wide and two bays deep with a two story brick "L" shaped wing two bays wide and four bays in depth with side galleries, partly enclosed. All brickwork is in common bond. The front entranceway occupies the left bay with a newer door, narrow sidelights, and a round arched transom of small panes. To the right is a very large, elliptically-arched triple window with richly moulded and fluted mullions adorned at the top of carved roundels and acanthus leaves. Second story windows are round arched with brick headers and 1/1 sash as below. Rear area windows are of 6/6 sash with wood lintels and sills. The attic is lighted by a small, four pane window in each gable. The front section has a rather steep slope "A" frame roof resting on two string brick cornices. Double flue enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. The house sets on a low fieldstone foundation but has high brick cellar walls, mostly above ground level.
