DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached brick pair of houses, six bays wide and two bays deep and share a two story brick "T" shaped wing three bays deep and four bays wide with enclosed side balconies and one bay deep rear extensions. All brickwork is of common bond. The front entrances occupy the outer bays with newer doors. #20 has a paneled enframement, newer Victorian stained glass small paned transom, and all is enclosed by Doric pilasters. The first floor of #20 is also fronted by a newer block and square pillared covered porch. A bay window with dentil trim occupies the center bay of this house. All other front windows are now of 1/1 sash with the lintels decorated by square end blocks with carved rosettes. Rear area windows are a combination of 6/6, 2/2, and 1/1 sash, all with wood lintels and sills. The attic of #20 is lighted by a 6/6 sash. The front section has a moderate slope "A" frame roof resting on three string brick cornices and double flue enclosed chimneys rise at each end and the center. The roof of #20 is covered by slate and #22 has a metal roof. The wings have rather flat roofs. The building rests on a low fieldstone foundation.
