**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#23 is a 2-1/2 story brick house detached on the left (W) side four bays wide and two in depth with a two story brick "L" shaped wing 1-1/2 bays wide and three bays in depth with a side balcony and one bay square dependency. The front facade is laid in Flemish bond, unusual for this street. The simple doorway occupies the second bay from the right with a newer door and is approached by a seven step porch. First floor front windows have been widened and are now of 2/2 sash. Those on the second story remain 6/6 sash and all have wood lintels and sills. Rear windows are mostly 6/6 sash with wood lintels and sills. The attic is lighted by two small windows in the left gable. The front section has a steep "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. The house sets on a high fieldstone foundation with the cellar mostly above ground and with a front entrance. The house is fronted by a brick pavement in a basket-weave design.
