DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#28 is a 2-1/2 story brick house detached on the left (E) side, three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and four bays deep with a side balcony and newer block extension. All brickwork is in common bond. The classic front entranceway occupies the right bay with a newer glass over panel door, two pane transom and paneled enframement. The whole is enclosed by plain pilasters bearing large cyma curved grooved brackets with foliated endings. Those are topped by paneled cubes which support and overhanging flat entablature. All front windows are of 2/2 sash with wood lintels and sills and louvered shutters. Rear windows are of 6/6 sash with wood lintels and sills. The attic is lighted by two, four pane windows in the left gable. The front section has a moderate slope "A" frame roof resting on three and two string brick cornices and a double flue chimney rises from the left. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
