DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#30 is a 2-1/2 story brick corner house three bays square with a two story brick "L" shaped wing approximately two bays square and newer brick side and rear extensions. All brickwork is in common bond and the front has been covered by formstone, including the high covered porch across the facade. There is a newer glass paned door in the center bay with a Victorian small-paned transom. All front windows are of 6/6 sash and rear area windows are of 2/2 sash with wood lintels and sills except for a side bay window which is dentil trimmed. The attic is well lighted by newer triple window shed dormers on the front and rear; two 6/6 sash windows in the right gable; and by a skylight. The front section has a medium sloped "A" frame roof of slate with a boxed cornice on the front. Double flue chimneys rise from near the ridge on the front slope. The wing has a rather flat roof. The house sets on a high fieldstone foundation.
